

I Mary Rippington of the Parish of Aldenham in the County of Hertford Spinster do declare this to be my last Will I bequeath to William Rippington of Aldenham aforesaid ffarmer one hundred and eight pounds sterling to my Nephew John Rippington of _____ in the County of Middlesex Butcher the Son of my late Brother John Rippington deceased one hundred pounds to Ann Collingridge the Wife of James Collingridge of Aylesbury in the County of Buckingham one hundred and fifty pounds to Elizabeth Gurden Wife of Richard Gurden of Oxford in the County of Oxford Innkeeper two hundred pounds to Mary Berry the Wife of _____ Berry of Summer Town in the County of Oxford aforesaid Wheelwright one hundred pounds and to Charles Rippington of Upper Marylebone Street in the said County of Middlesex nineteen pounds nineteen shillings and I give and bequeath unto the said above named William Rippington all and whatever money may be or become due or ultimately payable to me under or by virtue of a certain Suit in the High Court of Chancery originally instituted by Richard Tipping Rippington against Thomas Croxford Spiers of Thame in the County of Oxford aforesaid _____ or under or by virtue of the Will of my late Uncle Thomas Rippington deceased and I bequeath the residue of my Personall Estate of every description which shall remain after payment of my debts funeral and testamentary expences unto the said William Rippington Ann Collingridge and Elizabeth Gurden equally and I appoint the said Richard Gurden and Charles Rippington Executors of this my Will In Witness whereof I hereunto set my hand this seventh day of March in the Year of our Lord one thousand eight hundred and forty four _ Mary Rippington

This is a Codicil of my Will of the ffurniture linen and plate of Mary Rippington of Woodeaton I give to my Brother William Rippington my Mahogany Chest of Drawers and Bureau also my Clock and small Mahogany Cotton Box likewise the ready money which I have by me at the time of my decease and also the interest which is due to me in the Bank of England I gove to my Sister Mrs Collingridge my Oak Chest of Drawers Dressing Table Swing Glass and small Oak Table and Wash and stand a ffeather Bed Bolster and two Pillows a pair of Blankets and Bed Quilt a pr of Table Spoons marked M R and also the whole of my wearing apparel except my sngle Black Cloth Shawl trimmed with Silk fringe which I wish to give to Mrs William Rippington Mrs Collingridge is to have my Mahogany Work Box and two small White Boxes I Give to my Brother Thomas a silver Pepper Caster and one Table Spoon marked R R I give to my Niece Mrs Cannon my Chairs Corner Cupboard Linen Chest and China which are all at Marston and also my Silver Sugar Tongs which are here I give to my Niece Mrs Berry a pair of Table Spoons marked R E S and also a Caddy Spoon I wish for

the whole of my linen and Bed quilts to be equally divided between Mrs Collingridge Mrs Cannon and Mrs Berry part of my linen is here
