Merchant at the Bridge ffoot Lewes in the County of Sussex one pair of Silver Shoe Buckles and as to all the remainder of the said Sum of sixty Pounds in the Stock as aforesaid after payment of the before mentioned Debt and Legacy to the said Sarah ffussell together with all my Boxes wearing Apparel and what other Effects I may be possessed of at the time of my decease I give and bequeath to my said two Brothers to be divided between them equal share and share alike and lastly I do hereby nominate constitute and appoint my said Brothers Joseph Rippington and Samuel Rippington Executors of this my Will hereby revoking and making void all former and other wills or Testamentary dispositions by me at any time heretofore made and declare this only will and Testament In Witness whereof I the said William Rippington the Testator have to this my last will and Testament set my hand and Seal the twenty second day of July one thousand seven hundred and seventy eight William Rippington
